Industry type	Definition and scope
1. Metals smelting industry	Metals smelting industry using minerals as raw materials, includes copper, zinc, cadmium, aluminum, nickel, lead, and steel smelting industries.
2. Electric arc furnace steel smelting industry	Electric arc furnace steel smelting industry using scrap iron as a raw material.
3. Oil refining industry	Refining industry using petroleum as a raw material.
4. Basic petrochemical industry	Refers to the petrochemical basic raw material manufacturing industry, includes manufacturers of ethylene, propylene, butane, isoprene, aromatic hydrocarbons, and other basic raw materials.
5. Pulp industry	Chemical pulp manufacturing industry using rice straw, bagasse, wood chips, and bark as a raw material (includes rayon pulp).
6. Cement manufacturing industry	Cement manufacturing industry using minerals as raw material.
7. Pesticide technical grade manufacturing industry	Refers to the pesticide technical grade synthesis and manufacturing industry (excluding the processing industry with no synthetic operations).
8. Coking industry	Coke manufacturing industry using coal as a raw material.
9. Titanium dioxide manufacturing industry	Titanium white manufacturing industry using titanium minerals as a raw material.
10. Heavy metal stearate stabilizer manufacturing industry	Excluding manufacture using the fusion method.
11. Asbestos industry	Refers to the processing industry employing asbestos as its main raw material.
12. Leather industry, with applications for establishment of factories outside a park filed after April 13, 2018	Industry using raw, tanned and wet-salted hides as raw materials which will undergo a “wet-operating” tanning process to manufacture leathers (excluding dry-operating processing industry).
13. Intermediate	Industry using petrochemical basic raw materials to produce

petrochemical raw materials industry, with applications for establishment of factories outside a park filed after April 13, 2018	intermediate raw materials or products.
14. Plastics and rubber manufacturing industry, with applications for establishment of factories outside a park filed after April 13, 2018	Industry manufacturing plastic and rubber products through polymerization (excluding distribution and processing without polymerization).
15. Man-made fiber industry, with applications for establishment of factories outside a park filed after April 13, 2018	Refers to the industry manufacturing all types of synthetic or regenerated fibers (such as rayon fibers).
16. Textile dyeing and finishing industry, with applications for establishment of factories outside a park filed after April 13, 2018	Includes washing and dyeing plants (but excluding textile industry enterprises with no dyeing & finishing operations).
17. Electroplating and anodizing industry, with applications for establishment of factories outside a park filed after April 13, 2018	Refers to specialist enterprises engaging in electroplating and anodization.
